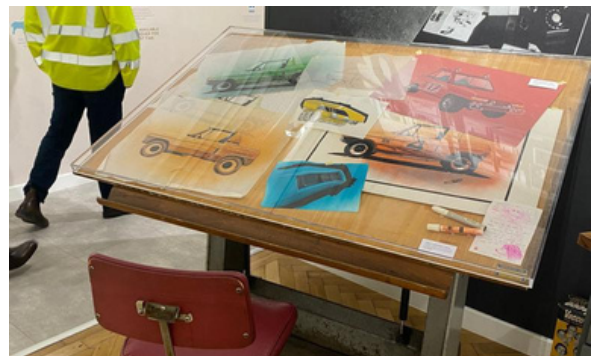

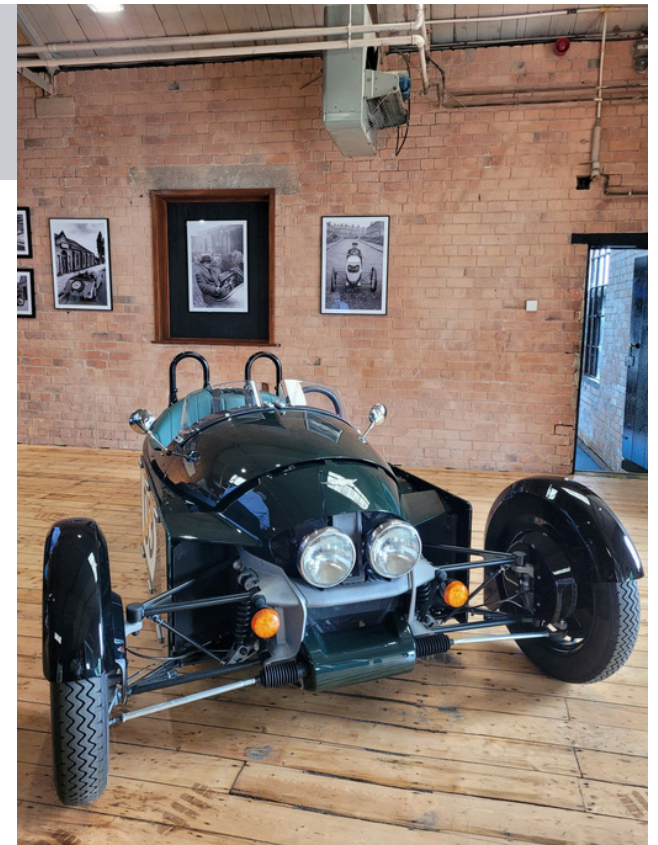
All five alumni highlight the quality of the programme and how it has helped them in their careers.

For Rebekah, the opportunity to reflect on her practice was valuable. *“You’re guided through the academic models by experts and because you’re with your colleagues and peers you’re in a position to think about those models, challenge them and do more research if you want.”*

Felix comments: *“I now have building blocks that I use in my day-to-day work of investing in distressed businesses and turning them around.”*

Aneesh says the programme introduced him to new concepts and helped develop existing skills, which in turn have advanced his professional development. He says: *“It’s given me more confidence in the market and to focus on leading rather than doing.”*

As well as the formal learning opportunities, Toby emphasises the value of his mentor on the programme. *“It was valuable to be able to talk to someone 10 to 15 years ahead in their career as an interim manager, especially because I was an independent and didn’t have senior people in my organisation I could turn to for advice.”*



Understanding the Turnaround Jigsaw

Aga says: *“Being able to look at a situation alongside other professionals who have different objectives to you is very eye-opening. It teaches you how to get to the same point more quickly.”*

Aneesh appreciated the insights too. *“Understanding how we all fit together in the jigsaw of advisors involved in a turnaround situation was really useful for me.”*



Building a Closer Connection with the IFT



Alongside building a greater understanding of the turnaround process and the turnaround community, the alumni highlight the opportunity to build closer ties with the IFT itself.

Aga has now joined the IFT as an accredited member, and both Felix and Aneesh plan to take that step.

Aneesh comments: *“The IFT is across my desk most weeks now, whether it’s attending an event, speaking at a conference or just coming up in conversation when I’m having coffee with someone. Being part of the Academy really opened my eyes as to what the IFT is about and how embedded in the turnaround community it is.”*

Growing Your Network

The Academy more than lived up to Toby's expectations of its networking benefits. He says: "I changed careers recently and my job involves sourcing investments and opportunities. The Academy has proved super-helpful in giving me a network of people I can turn to for help and vice versa."

The network proved an important benefit for Aga, Aneesh, Felix and Rebekah too.

Aga says: "I had a rich network of contacts I'd built up over the years that were valuable in my previous role, but when I started my current role I had to grow a new network from scratch. Being part of the Academy was the perfect opportunity to accelerate that growth."

Felix adds: "I'm still in touch with a number of my cohort as well as encountering them in transactions. It broadens your network, especially in some more specific areas that you wouldn't necessarily see in your day-to-day role."

Rebekah comments: "Because you're with people over the course of a year, you can build some genuine, authentic relationships."
